

Jimi Mitsunaga was a Nisei born on March 5, 1934, in Salt Lake City, Utah. He passed away on Jan. 31, 2022. He was predeceased by his wife, Barbara Keiko Mitsunaga, and is survived by their four children, Janice, Darrell, Tracy and Hollis, seven grandchildren and two greatgrandchildren.

Jimi received both his BS and LLB degrees from the University of Utah in 1958. He was one of the first 50 minority attorneys in Utah and worked

Jimi was the founder and first director of the Salt Lake Legal Defender Association of Utah and also founded the Asian Association of Utah. He served the community in many capacities including as president of the Utah Minority Bar Association (UMBA), president of the Salt Lake Japanese American Citizens League, chairman of the Criminal Law section of the Utah State Bar and chairman of the Governor's Asian Advisory Council for the State of Utah.
